
Model CRA000AD - G3 to CR1/CR3 Adapter Panel Bulletin

GENERAL DESCRIPTION

The Model CRA000AD adapter panels provide the necessary hardware to install a CR1000 or CR3000 into an existing cutout where a G3 unit was installed. These panels are coated with a durable black finish that matches the color used on the CR1 and CR3 series HMI. Included in the kit are the necessary nuts, washers and panel gasket required to meet any NEMA 4X/IP66 (Face only) application.



MOUNTING PROCEDURE

- 1. Remove existing G3 HMI from panel, including old panel gasket.
- Install new G3 to CR1/CR3 adapter panel into existing G3 cutout using the supplied new panel gasket. For the CRA000AD1010 only, also install the adapter strips as shown in the Figure 1.
- 3. Install supplied nuts and washers onto panel adapter and tighten evenly for uniform gasket compression.
 - Note: Tightening the nuts beyond a maximum of 17 inch-pounds (1.92 N-m) may cause damage to the front panel.
- 4. Install replacement CR1/CR3 unit into adapter panel using the mounting clamps supplied with the CR1/CR3 unit. DO NOT use the panel stiffener plate supplied with the CR1/CR3 units. It is not needed (nor will it fit) when the panel adapter is used. Tighten the mounting clamps to 4.0 pound-force inch (64 ounce-force inch) (0.45 Nm) evenly for uniform gasket compression.

CAUTION: DO NOT OVERTIGHTEN THE CLAMPS.

Figure 1: Adapter Strip Installation for CRA000AD1010





Figure 2: CR1/CR3 Unit Installation
